COPE Increase 1.30%

The DSS has now published the new rates of payment for aged care subsidies and supplements from 1 July 2015, and the COPE increase is **1.30%**. We are pleased to note that it was extremely close to our final projections of 1.28% (See our *Ageing Matters* dated 8 May 2015)
